The members of the Technical Committee and the representatives of the bidders attended the meeting.

- 4. Additional Director (Procurement) explained in detail the technical specifications regarding Procurement of Laptops (Lot 1 & Lot 2).
- 5. The representatives of the bidders sought certain clarifications which were addressed by the technical & procurement team of PHCIP and responded hereunder: -

 - ii) Bidders shall submit their bids in a secure binding form. Bids received in clip folders shall not be acceptable.
 - The documentation required in the Section II Bid Data Sheet (BDS) & Section IV-Bidding Forms, ought to be complied very carefully.
 - iv) All pages of the bids should be numbered, signed/initialed and stamped by an authorized representative.
 - v) RFB document's Section I Instructions to Bidders including Bid Data Sheet, must be read and understood carefully.
 - vi) Most Advantageous Bidder (lowest evaluated bidder) will also provide e-Stamp Paper as per the value of contract at the time of signing of contract.

7. During the discussion, representatives of the bidders were also briefed with respect to the evaluation criteria and other eligibility requirements specified in the RKB document.
